

INDEX OF INFORMATION ABOUT THE CONFLICTS IN THE GREAT LAKES REGION PUBLISHED IN THE NEW VISION NEWSPAPER, FROM 1997-2001.

This survey was conducted by Mr. Kassim Musa Kamuhanda, as a dissertation for the award of the degree of Bachelor in Library and Information Science at Makerere University, Uganda, under the supervision and guidance of Professor Syed A. H. Abidi

ABSTRACT

This report gives the results of the survey conducted to prepare an index of the information published about the conflicts in the Great Lakes Region in the New Vision Paper. The research had three objectives viz:

Locate the New Vision Newspapers in which information about conflicts in the Great lakes region have been published, make a record of the entries on data cards, and establish to what extent has the New Vision Paper covered the conflicts in the Great Lakes region. The research problem is that, there is no specific index of the news published about the conflicts in the Great lakes Region. The major finding is that the New Vision Newspaper covers almost all major conflicts taking place in the Great lakes Region, as frequently as at least every after three days especially during the period 1997 - 2001. Recommendations were that the exercise of indexing information about the conflicts in the Great Lakes Region should continue to be undertaken and the process of indexing extended to cover other areas of study e.g. Research. It was also recommended that libraries should avail indexes to users and also teach them how to use them. It was also recommended that a computer-based database be created out of the entries of the index to facilitate easy retrieval, speed and accuracy, updating of the index and guiding the users and researchers.

CHAPTER ONE

INTRODUCTION

1.0 This chapter introduces the background to the study, significance of the study and the hypothesis.

1.1 BACKGROUND TO THE STUDY

This study is an index of information published about the conflicts in the Great Lakes Region, in the New Vision Newspaper, from 1997 - 2001. According to Mafeje Archie (1998), the Great Lakes Region is an area between and around the Great east African Lakes of Tanganyika, Victoria, Kyoga, Albert, Edward, George, Kivu to mention but a few. People living in this area are mainly Bantu speakers such as people from Bunyoro, Toro, Bukonzo, Ankole, Busoga, Rwanda, Burundi, Buzinza, Buganda, people from Eastern Democratic Republic of Congo, from areas like Kisangani, Goma, Kivu and so on.

The countries in the Great Lakes Region are Uganda, Tanzania, Democratic Republic of Congo, Rwanda Burundi. These countries have experienced a number of conflicts for a long time.

The Great Lakes Region has for a long time been a conflict zone, characterized by several armed conflicts such as inter-state conflicts where by countries fighting each other; countries fighting dissidents, intra-country clashes which involve tribal clashes; rebels trying to destabilize government and many other conflicts.

According to New Vision March 6, 1997 p.12 (4-6) Fighting in Eastern Zaire and an influx of refugees back to Rwanda has made the local population inaccessible to relief agencies are caught up in the middle of the fighting in the conflict zone. Fighting led to human suffering and loss of life.

Inter-tribal clashes in the Eastern Democratic Republic of Congo (DR Congo), for example conflicts between the Heme and Lend, led to severe suffering and deaths.

More tribal clashes were experienced in Rwanda and Burundi, for instance among the Hutus and Tutsi tribes, Hutu Banyamulenge fighting the Mai Mai tribes.

Other conflicts included countries fighting each other or one country supporting dissidents of another country. For example DR Congo harboured and supported the ADF rebels against Uganda. Uganda also responded by supporting rebels against DR Congo such as MLC rebels and RCD Kisangani rebels. Rwanda and Burundi also supported rebels against DR Congo government such as the RCD Goma rebels. Other countries outside the Great lakes Region also came in to assist DR Congo. Countries like Angola, Zimbabwe, Chad poured troops in DR Congo to help DR Congo in fighting the rebels who had taken 55% of DR Congo.

Due to the above attacks and counter-attacks including foreign troops involvement, the Great Lakes Region became an area of armed conflicts, which led to the death of several people including children.

The Great Lakes Region being a region characterized by several conflicts as mentioned above, became a focus of concern not only for a Ugandan community but the International community as well. Due to severe deaths and sufferings caused by the conflicts in the Great Lakes Region, International Bodies such as United Nations, European Union felt concerned about the tough situation in the Great Lakes Region. The international community therefore, responded by intervening in an attempt to end the conflicts in the region for instance deploying troops between UPDF and RPA in an attempt to end the clashes between UPDF and RPA in Kisangani as noted in New Vision. June 13, 2000 (p.1&2). European Union (EU) has also tried to intervene by inviting leaders of the Great Lakes Region for talks.

However, all efforts put in to end the conflicts in the Great Lakes Region have failed.

The conflicts are still going on. Therefore because of such endless conflicts, the Great Lakes Region has for a long time been the focus of attention and concern by the Region and more so, by the international community and consequently the media.

The New Vision is a daily Newspaper published by the New Vision publishing corporation that was established in 1987, as a government owned parastatal. The paper is one of the Uganda's largest dailies circulated throughout the major towns of Uganda. The paper also penetrates deep in suburbs of Uganda's major towns. It also crosses borders sometimes to neighbouring countries like Kenya, Rwanda, DR Congo and Tanzania.

The New Vision has covered conflicts in the Great Lakes Region as an important point of concern and attention. The coverage of conflicts in the Great Lakes Region helps the Newspaper in fulfilling its duty of informing the society about the conflicts in the Region. It helps the community to keep informed and up-dated about what is going on in the Great Lakes Region. People, who cannot reach all areas in the Great Lakes Region, find it difficult to know about the conflicts in the Great Lakes Region.

1.2 THE RESEARCH PROBLEM

Since 1987, when the New Vision Newspaper was established, there has been a great accumulation of articles and issues about the Great Lakes Region.

This has made the location and retrieval of past issues a slow and tedious process. The problem is that there is no specific index of news published about the conflicts in the Great Lakes Region. There is thus a need for a reference tool that would facilitate a faster and easier system of retrieval of articles about the conflicts in the Great Lakes Region. One of the best tools is an index.

1.3 SIGNIFICANCE OF THE STUDY

An index is an important guide to researchers and politicians in the Great Lakes Region. By facilitating the location and retrieval of articles and issues about the conflicts in the Great Lakes Region, the index helps the researchers and politicians to easily access the information they want about the conflicts in the Great Lakes Region.

The index will help the leaders in the Great lakes Region in finding solutions to the conflicts.

The index will act as a finding list for information to users in libraries and information centers (such as researchers, students and laymen), so they do not get much trouble in locating the articles. It will also be an additional reference tool to the library.

1.4 AIM OF THE STUDY

The aim of the study was to produce an index of the issues published in the print media, with special reference to the New Vision newspaper, about the conflicts in the Great lakes Region.

The index will eventually aid in the easy reference and retrieval of information about the conflicts taking place in the Great Lakes Region.

1.5 OBJECTIVES OF THE STUDY

- 1 To locate the New Vision newspaper in which conflicts in the Great Lakes Region have been published
- 2 To make a record of entries about the conflicts on data cards
- 3 To establish to what extent has the New Vision covered the conflicts in the Great Lakes Region

1.6 HYPOTHESIS

The conflicts in the Great Lakes Region not frequently covered in the print media

1.7 VARIABLES

The independent variable considered in the study is the Great Lakes Region about which articles and issues about the conflicts in the region are published in the New Vision newspaper. The dependent variable is the 'conflicts'.

CHAPTER TWO: LITERATURE REVIEW

2.0 INTRODUCTION

This chapter presents documentary analysis of literature about indexing, relevant professional and scholarly literature was carefully studied.

2.1 INDEXING

According to Rothman, "Indexing is the process of creating entries in an index". An index therefore is a list of topics or subjects covered in a book arranged alphabetically against each correspondent page.

2.2 TYPES OF INDEXES

There are different types of indexes, which include the following:

1. Classified indexes: These are known as guides to specialized situations such as economic names but also to general subject. The arrangement in this hierarchy of related topics starting with generic topics down to specific and are useful for generic searches when the retrieval assuming for cases of documents.
2. Author Index: Here users are guided to title of documents by way of authors. It comprises of an alphabetical author name accompanied by document number, classification number of citation.
3. Alphabetical subject index:
This is based on the orderly principles of letters of alphabets and it is used for the arrangement of sub-headings, cross-references and qualifying terms as well as main heading.
4. Coordinate index: These are created by combining two or more single index terms to create a new class.
5. Faceted indexes: These are pro-coordinate classification order, rather than alphabetical order. The terms are not exhaustive like in the classification system before intended to be used as building books.
6. Citation indexes: This consists of all articles, with a sub-list under each article of subsequently published papers, which cite the articles. It has

a different approach because the Author is the most qualified person to define and delineate related materials most relevant to his subject. It also gives a clear channel between the author and user without use of artificial language.

7. Permeated title indexes: These are created by systematically rotating information conveying words in the title as subject entry points into the index. The title is the only component of a document in which the author tries to indicate what the subject of the text is about.
8. Chain indexes: This is a method that attempts to minimize these by presenting the single entries in classified index, one by one in an alphabetical list. These indexes provide that every concept becomes inked or chained to its directing related concept in the hierarchy system.
9. Presented contact index system (PRESCIS). This is closely related to computer manipulation and in fact, evolved out of the BNS's interest in using MARC records and being involved in chain indexing techniques.

This system is automatic-oriented; the patron enters the alphabetically arranged index with a significant item and can see the use of the terms by the author in its context.

2.3 THE IMPORTANCE OF INDEXING:

The objective of any index is to retrieve the records and documents that have been stored and organized by the indexing process that created a description of a document or information usually in an accepted format. Rowley (1988) writes that indexes are important components of mainly primary and secondary publications as well as current awareness services and computer databases. He emphasizes that indexing is a process of being able to retrieve the records or documents that have been stored or recognized by the indexing process. In emphasizing the above he says, "A searcher needs to appreciate indexing principles in order to enhance the possibility that will bring the appropriate document or information profile to the index".

An index is important as a tool of document analysis and a document analysis makes a significant contribution to communication and information flow.

Indexes are convenient guides and lead users to written works. Users usually want

much more specific information than merely the titles of books in the collection.

Usually it is difficult and tiresome to look through all the newspapers for particular articles of information, e.g. looking for information about conflicts in the Great Lakes Region in New Vision newspapers.

Indexes provide an integrated picture that no bibliographic tool can provide. In line with the above Landu (1966) points out that a good index is one with a complete analysis of the book in which entry is related to similar subjects, the evolution of thought is properly demonstrated, and no significant idea of fact is left unmentioned. All indexable material is covered. According to Landu, "The contemporary aim of indexing is to ensure that everything which can possibly be regarded as useful is indexed if space allows".

An index helps to organize literature so that the specialist can identify document of interest more easily. It therefore guides a user to the intellectual content and physical collation of documents.

An index as noted earlier is a pointer or guide, therefore it does not generally supply the desired information itself, but instead, it employs a set of tags or descriptors, which earmark the sound of information for which the user is searching. Each user is directed by the index the author in the knowledge records.

An index also reflects the subject observed in the document. And in the case of subject arrangement, selected subjects will be put together assuming that users are accustomed to logical arrangement of knowledge and is natural for them to search this way. However indexes vary in quality and completeness as Kumar, Krishan (1996) puts it.

He says newspaper indexes are generally of two types:

- 1 - Indexing many newspapers and
- 2 - Indexing a single newspaper. He further says, "The basic order of arranging headings is alphabetical, word by word, alphabetically, letter by letter within the word. Entries can be located by date, page and

column reference. A glance at the index will enable one to do a news analysis of the contents”.

2.4 LEVELS OF INDEXES

- 1- Word and name indexes: Sometimes these are called concordances. They are indexes to individual words and names that the author used to present the information and ideas he had in mind when creating the manuscript. These are values to users because the exact term or word within the context of the document will pin point the subject discussed and its location. An example of this is a Bible concordance.
- 2- Book Indexes:
This makes up a large category of indexes. The readers are quite familiar with book indexes. These are lists of words, alphabetically arranged at the back of the book, giving page location of subject or names associated with each word. This kind of index also pin points information so that the reader will not have to read or re-read the whole book. An example of Book Index is the encyclopedia Britannica, especially the macropodica volume.
3. Periodical indexes: These are based on the same principles and objectives as book indexes, but their scope is broader and it covers mainly unique problems. They are usually open-ended. Product prepared by many people and each issue of a periodical may deal with unrelated topics, written by different authors, in different users' needs.
4. Information retrieval system indexes: This is defined as the selection of systematic recall of logically stored information. The use of this system requires especially electronic computing machines.

As already analyzed, the purpose of indexing is for storage and subsequent retrieval of the records, which eventually lead to the documents, and the information contained therein. Therefore, an index of conflicts in the Great Lakes Region published in the New Vision newspapers from 1997 - 2001 will provide a reference tool to the conflicts taking place in the Great Lakes Region from the viewpoint of the press.

CHAPTER THREE: METHODOLOGY

3.0 INTRODUCTION

This chapter presents the research method used, population description, the sample and sampling method, scope and coverage, research instruments, data processing and presentation, limitations and opportunities.

3.1 RESEARCH METHOD

The researcher used survey study applying documentary analysis by examining information published by the New Vision newspaper about the conflicts in the Great lakes Region.

3.2 POPULATION DESCRIPTION

The population is the print media. The New Vision newspaper was considered. Information about conflicts in the Great Lakes Region published in the New Vision newspaper was examined.

3.3 SAMPLE

The researcher sampled issues and information about the conflicts in the Great Lakes Region published in the New Vision newspaper from 1997 - 2001.

3.4 SAMPLING METHOD

The researcher used systematic sampling by considering issues and information published in the New Vision newspaper about conflicts in the Great Lakes Region in a specific period of time that, is between 1997 and 2001.

3.5 SCOPE

The index covers information published in the New Vision newspaper about the conflicts in the Great Lakes Region in the period between 1997 and 2001.

3.6 COVERAGE

The index covers all headlines or titles of information about the conflicts in the Great Lakes Region. The articles provide information about the Great Lakes Region. The

articles provide information about inter-ethnic clashes, clashes between UPDF and RPA, dissidents, defectors, conflicting rebel groups, treason charges, foreign troops involvement and so on as provided by the subject headings.

3.7 RESEARCH INSTRUMENTS

Data cards were the main tools used. Entries were made on the cards including the titles of the articles, name of the author, date of publication, the publisher, the page, and columns covered by the article. The cards were arranged using the card sorter.

3.8 DATA PROCESSING

The entries on cards were edited manually to correct errors. They were then processed using MS-Word.

3.9 DATA PRESENTATION

The general entries came first and the rest of the entries of the index were arranged alphabetically from A to Z according to the subject headings and the sub-headings within the subjects, are arranged chronologically according to dates of publication. Entries of the same date of publication were in turn arranged according to the alphabet. The index was alphabetically arranged according to subjects got from the sears list of subject headings 15th edition and library of congress list of subject headings.

After the subject headings, title of the article, writer publisher, date of publication, pagination and lastly column number (in that order), as shown in the example of one article below:

All other articles under the subject heading above are being included.

3.10 LIMITATIONS

The major problem encountered was that of the missing issues. Some pages were missing. Makerere University Library also takes long to bind the newspapers.

This costed the researcher a lot while collecting entries from unbound newspapers. The recent newspapers like those of 2000 -2001 were not bound. Due to the above problems of missing pages in the newspapers, the researcher had to spend a lot struggling to look for the missing pages elsewhere.

3.11 OPPORTUNITIES

The researcher was atleast covered in many articles and issues of the New Vision newspaper from 1997 to 2001. This helped the researcher in quick location of information about the conflicts in the Great Lakes Region.

CHAPTER FIVE: CONCLUSIONS AND RECOMMENDATIONS

5.0 INTRODUCTION

Indexing, an information search and retrieval system, was the concept of this research. The laws of Library and Information Science state that:

- 1 Books are for use
- 2 Every user his book
- 3 Every book its user
- 4 Save time for both users and the staff
- 5 Library is a growing organism.

In order to comply with the laws of Library and Information Science stated above, information materials should be arranged mechanically in a helpful sequence, like items grouped together, a process that would save time in retrieval. Similarly, the task of producing this index was to present to the user or researcher with a finding list for his/her information needs. In this case, publications about the conflicts in the Great Lakes Region in the print media (New Vision newspaper) were indexed to serve the purpose mentioned above. This chapter therefore presents conclusions and recommendations about the index.

5.1 CONCLUSIONS

1. Five hundred thirty entries of information about the conflicts in the Great Lakes region were made considering that an index covered five years (from 1997 - 2001). It is therefore concluded that roughly two articles about the conflicts in the Great Lakes Region are published by New Vision newspaper every after 3 days, especially during the period from 1997 to 2001.
2. There are more entries about inter-ethnic clashes, clashes between UPDF and RPA, Dissidents and Governments pursuing dissidents than any other subject in the newspaper.

3. Entries revealed that there are many conflicts in the Great Lakes Region. This indicates that there is a need for solutions to the conflicts in the region.
4. Basing on the findings in chapter 4, the hypothesis as stated in 1.6 is proved false. New Vision newspaper covers most of the conflicts taking place in the Great Lakes region as frequently as every after three days on average.

5.2 **RECOMMENDATIONS**

1. Since indexes act to guide the users to the existing material, they are a finding list important in reference work. Indexing of information about the conflicts in the Great lakes Region should continue to be undertaken. This will ensure accessibility and quick retrieval of information about the conflicts in the Great Lakes Region. Enough information about the conflicts in the region can also help in the peace process.
2. The work of preparing and compiling indexes is a complex task. The researcher recommends that a computer-based database be created out of the entries of the index. CDS/ISIS (Computerized Document System/Integrated Set of Information System. Dbase and other Database Management Programmes which are useful. The databases if introduced will facilitate easy retrieval and updating of the index, and more so they are speedy and accurate.
3. It is also recommended that the Library should carry out user education sessions especially for the new users, to teach them how to use the index, and also to explain the difficult terms if need arises.
4. Indexing should be extended to cover other areas of study e.g. research if resources are available. Indexes should be made available to users. They should not be hidden
5. The researcher also recommends that the exercise of indexing be carried out periodically, and updating of indexes should also be considered.
