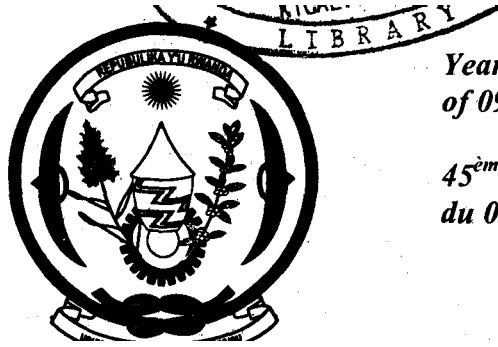

**MINISTERIAL ORDER N° 01/06 OF 08/02/2006 DETERMINING THE MODALITIES FOR MERGING THE EXECUTIVE COMMITTEES OF THE NATIONAL WOMEN'S COUNCIL ORGANS AT THE LEVEL OF CELLS**

**The Minister in the Prime Minister's Office in charge of Family Promotion and Gender;**

Given the Constitution of the Republic of Rwanda. of June 4, 2003, as amended to date, especially in its Articles 120, 121, 187 and 201;

Given the Organic Law n°29/2005 of 31/12/2005 determining the administrative institutions of Rwanda;

Given Law n° 27/2003 of 18/08/2003 determining the organisation, attributions and functions of the National Women's Council, especially in its Articles 5, 9, 10, 11, 12, 13, and 14;

Considering the Ministerial Order n° 01/07.04 of 28/01/2006 determining the demarcations of Cells;

After consideration and approval by the Cabinet meeting in its session of 08/02/2006,

**HEREBY DECREES:**

**Article One:**

This Ministerial Order determines the modalities for merging the Executive Committees of the National Women's Council Organs at the level of Cells.

**Article 2:**

The Executive Committees of the National Women's Council Organs: at the level of Cells shall be merged in conformity with the Ministerial Order n° 01/04 of 29/12/2005 determining the modalities for merging the Executive Committees of the National Women's Council Organs at the level of Sectors, Districts, Provinces and Kigali City.

Under the terms of this order, the Executive Committees of the National Women's Council Organs that shall be merged are the Committees at the level of Cells, and the elections aimed at merging them will only be organised in places where the Cells in place before the publication of the Ministerial Order n° 01/07/04 of 28/01/2006 determining the demarcations of Cells have been merged in conformity with this order.

**Article 3:**

This Order shall come into force on the day of its publication in the Official Gazette of the Republic of Rwanda.
